

HON. JOHN P. DiBLASI (RET.)

Justice of the Supreme Court, Westchester

Hon. John P. DiBlasi was a consummate jurist and has an exceptional reputation as an ADR professional. He became a Justice of the Supreme Court of the State of New York at the age of 39, one of the youngest in the history of the state. He was the first Presiding Justice of the Commercial Division of the Supreme Court, Westchester County, where he presided over complex commercial litigation involving contracts, employment, real property/land use matters and environmental litigation. He also created the Alternative Dispute Resolution Program used successfully by this Court.

While on the bench, Judge DiBlasi developed extensive experience in the trial and settlement of complex commercial and personal injury matters. Since his departure, Judge DiBlasi has committed himself to a full-time ADR practice. He has developed a reputation for settling even the most complex matters and is persistent in following up with parties weeks and sometimes months later (post-mediation), in an effort to assist the parties in reaching a resolution. As an arbitrator, Judge DiBlasi has the skills necessary to digest and analyze expert testimony, complex contracts and documents, as well as the ability to render prompt and reasoned decisions. His experience encompasses a wide-variety of subject matter expertise; however, Judge DiBlasi can take on almost any subject matter that is brought before him, as he is known to be well prepared and adept at comprehending even the most challenging issues. Judge DiBlasi also maintains the highest rating of AV from the Martindale-Hubbell Peer Review Ratings System, attesting to his vast legal acumen and high ethical standards.

Some recent matters include a major entertainment law case involving a nationally syndicated media personality who was sued for libel arising out of the national broadcast of over the air comments; in addition to a complex personal injury case involving a young woman who was struck by a car and whose injuries allegedly caused her to develop a blood-clot which caused her death 6 weeks after the accident. Judge DiBlasi has also mediated and/or arbitrated hundreds of cases involving complex insurance coverage issues among multiple defendants; labor law cases where the injuries to employees have been in excess of seven figures; complex land use actions inclusive of large commercial developments, municipal projects, and allegations of non-compliance with SEQRA; and employment law matters involving sexual harassment, wrongful termination, claims under the Employee Retirement Income Securities Act, retaliation cases involving in-house “open door” policies, tortious interference with employment contracts and prospective business relations.

Judge DiBlasi is based in the New York Metro region but also hears cases throughout the country. In addition to his full-time practice in New York, he has handled significant, high-stakes matters in Boston, Chicago, Hartford, Las Vegas and Miami. He has facilitated the settlement of complex commercial litigation, personal injury, labor law, medical malpractice, entertainment law, land use and employment cases.
