

HON. JOSEPH N. GIAMBOI (RET.)

Justice of the Supreme Court, Bronx

Hon. Joseph N. Giamboi served as a Justice of the Supreme Court of New York, Bronx County from 1995 to 2002. He has a wealth of legal expertise having tried over three hundred cases, rendered in excess of five thousand decisions and helped to dispose of hundreds of matters through settlement efforts. Since his retirement Judge Giamboi presently serves as a mediator and arbitrator with NAM specializing in construction, personal injury, employment, investments and securities, and labor law matters.

Before his election to the bench, Judge Giamboi was a named partner in the law firm of Giamboi, Reiss & Squitieri for approximately thirty years, where he oversaw a variety of matters, one of which included representing several firms in litigation. In total Judge Giamboi has over forty-five years of expertise as a legal practitioner. He has practiced before the following U.S. Districts in Pennsylvania, Ohio, Florida, California, Colorado, Washington, D.C., Alabama and Tennessee. Judge Giamboi also played a very active role in his community having worked as a former administrative aide to Congressman Paul Fino; former administrative assistant to Senators Pericone, Pisani and Calandra; in addition to his service as Counsel to the New York State Board of Elections.

In 1997 Judge Giamboi was presented with the Charles A. Rapallo Award from the Columbian Lawyers Association for the First Judicial Department of New York State. The award is named for the late Charles A. Rapallo, the first Italian-American judge appointed to the New York Court of Appeals. He served the Court from 1870 to 1887. Past recipients of the Rapallo award include U.S. Supreme Court Justices Antonin Scalia and Samuel Alito Jr., former Governor Mario M. Cuomo and former Mayor Rudolph Giuliani.
