Shelley Rossoff Olsen was the Senior Court Mediator and Summary Jury Trial Judge in the Supreme Court, New York County, Civil Division. She has an extensive background in civil law and is highly respected by both the plaintiff and the defense bars. Ms. Olsen is known as an exceptional mediator and arbitrator, having settled thousands of matters in a wide variety of case types. She is considered to be an authority on alternative dispute resolution and facilitated settlements.

Prior to her work in the Court system, Ms. Olsen developed a strong background in litigation representing both plaintiffs and defendants in civil matters. She began her career as a private practitioner and quickly transitioned over to the District Attorney's Office in Nassau County in 1984 as an Assistant District Attorney, where she prosecuted over 30 jury and bench trials. Four years later, Ms. Olsen joined Bower & Gardner, one of the preeminent medical malpractice defense firms in New York City as a senior litigation attorney. At the 200+ attorney law firm, she successfully tried more than 100 complex medical malpractice cases. She continued her defense litigation practice at Martin, Clearwater & Bell, defending over 150 files for the New York City Health and Hospitals Corporation. After that Ms. Olsen concluded her trial practice as a plaintiffs' attorney at Trolman, Glaser & Lichtman, where she tried tort cases, including medical malpractice, labor law, lead poisoning, premises liability and personal injury.

In 2000, Ms. Olsen left trial practice to work as a court attorney at the Appellate Division, First Department, where she wrote extensively on issues including complex insurance issues, labor law, negligence, and employment discrimination for over five years. Her work in the Appellate Division, thoroughly prepared her for her eventual transition to Senior Court Mediator and Summary Jury Trial Judge. In 2010, she joined National Arbitration and Mediation (NAM) as a full-time mediator and arbitrator specializing in complex dispute resolution.
