STANDARD FEES AND COSTS for SPECIAL SERVICES



In some circumstances, different rates may apply to certain Specially Designated Hearing Officers. Hearing Officer Time for **Three (3)** Specially Designated Hearing Officers may range from \$2,670 to \$3,190 per hour split equally among all parties. Please consult with your NAM Account Executive for the applicable rates.

To the extent that the Tri-panel of Hearing Officers selected for the case includes a mixture of Regular and Special Rate Hearing Officers, the hourly fee will be adjusted proportionately.

| - 15 + Business Days Notice to NAM | \$470 flat fee or \$490 flat fee for a case with a specially designated hearing officer |
| Settlement Fee | Same as above for adjournments/cancellations except that each party will be billed these fees |

As applicable, the parties will be responsible for fees relating to Hearing Officer Time for the number of hours expended by the Hearing Officers before NAM is notified that a case has been adjourned/cancelled/settled.

STANDARD FEES AND COSTS for SPECIAL SERVICES



Fees relating to above services are total amounts due. If there is one party, that party is responsible for the full amount. If more than one party, the costs are split equally among the parties.

TRIAL PREPARATION SERVICES:

TERMS & CONDITIONS

- These fees ONLY apply to Tri-panel cases, Private/Mock Jury Trials, Videoconferencing and Trial Preparation Services. Please see NAM's separate Fee Sheet for Standard Arbitrations and Mediations.
- All Administrative Fees are non-refundable.
- Hearing Officer Time shall be defined as, but not be limited to, all case review time, study, research, decision preparation time, telephone or verbal conference time, as well as reserved and additional actual hearing/conference time (if needed).
- Hearing Officer Hourly fees are charged equally to all parties for the full duration of the hearing/conference/study and decision preparation time (regardless if any individual party is not present for the total time incurred).
- The parties are responsible for all time reserved.

STANDARD FEES AND COSTS for SPECIAL SERVICES



PAYMENT TERMS

Administrative fees and time reserved are due two weeks prior to the hearing date/date when services are to be performed, or upon receipt if date of hearing/service is less than two weeks from invoice date. All other fees are due within 10 days of invoice date. NAM may elect not to commence administration of the claim/services or not to allow the hearing/conference/services to proceed or to withhold the release of the Arbitrator's decision (as applicable) until all outstanding fees are paid. Interest will be charged at a rate of 1.5% per month on balances more than 30 days past due. Any questions or concerns regarding invoices should be brought to NAM's attention within 30 days of the receipt of the invoice.

Fees and costs are effective as of 7/1/18. All fees are subject to adjustment annually as of July 1st of each year.
