As a full-time Mediator with NAM, his integrity and legal acumen have earned him the respect and confidence of both the plaintiff and defense bars, as his case referrals are sourced equally from both sides, as well as directly from insurance carrier representatives. Mr. Ehrlich's years of practice have given him a deep understanding of the case evaluation nuances specific to many different types of cases and injuries. He is a longtime supporter of alternative dispute resolution and his expertise in complex negotiations makes him an exceptionally well rounded and effective mediator and arbitrator with NAM.
