Hon. Anthony I. Giacobbe was a New York Supreme Court Justice in Richmond County since his appointment in 2006, until his retirement in 2012. Immediately prior to this appointment, Judge Giacobbe sat in the New York Court of Claims and as an Acting Supreme Court Justice from 2000 to 2006. The Judge enjoys a distinguished career in both in the public and private sector; particularly in his decade long service as Supreme Court Judge and presently, as an arbitrator and mediator for NAM.

During his time on the bench, Judge Giacobbe presided over all civil matters including medical malpractice, personal injury, and contracts.
